AutoDoc, the automatic document delivery service of FIZ Karlsruhe, partners with scientific publishers, international document procurement services, and renowned scientific libraries in Germany and abroad, whose extensive holdings will most probably contain the article you are looking for. AutoDoc can be used either as a stand-alone web service or as part of the STN Full-Text Solution directly after searching the STN databases. It can also be integrated into intranets or portals.

### AutoDoc finds the best supplier for you

The AutoDoc system analyzes the order data and then forwards the order automatically to the appropriate supplier among our partners.

### Original color PDF documents directly from the publisher

The supplier will send the documents directly to you in the format you have chosen (PDF, fax, print). Whenever possible, AutoDoc will deliver original documents directly from the publisher in PDF format and full color.

### Link to Open Access sources

Within the scope of an open access check, AutoDoc offers links to journal articles from nearly 30,000 open access sources, if available.

### Minimize your administrative and billing effort

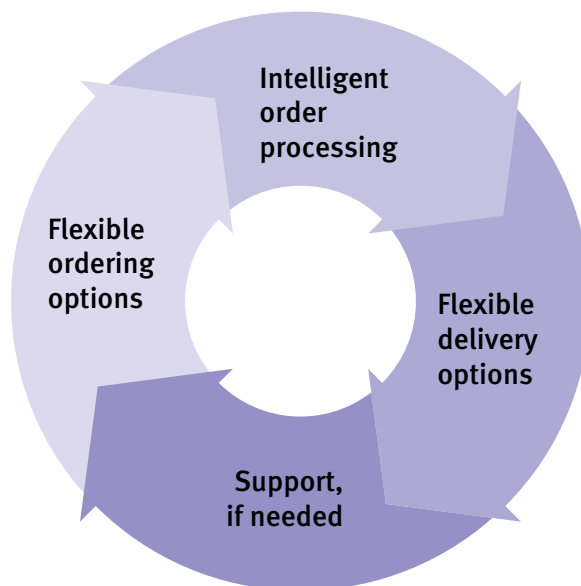

The supplier delivers the full-text document directly to you, in the speed and format (PDF, fax, print) you have chosen. FIZ Karlsruhe sends you a monthly collective bill covering all your orders placed with the different suppliers.

- Menu-guided interactive web order forms for journal articles, patents, and other literature are available.

- Transfer of order data from other search interfaces/ databases, e.g., CAS SciFinder®, Scopus, Reaxys®, XPAT®, etc.

  - For your convenience we have also installed a human link to AutoDoc: Our service team accepts orders by (unformatted) e-mail or fax.
5. Optionally enter comments, reference numbers, cost centers, and request notification e-mail.
  6. Click “Proceed”.

AutoDoc analyzes your data and assists you if your input is incorrect or incomplete. A duplicate check is also included. Before you finally submit your order, a page with “Order Details” is displayed where you can review all order information and costs, incl. alternative delivery formats and links to open access sources (if available). This gives you full control of your costs.

The individual AutoDoc order number allows you to continuously track the status of your order.

### Convenient document ordering via menu-guided order form:

Enter your order into the interactive AutoDoc order forms see image:

1. Select the “Classic Order” form (for journal articles, other literature, or patents).
2. Select the document type.
3. Enter DOI or bibliographic information (journal title, ISSN, year of publication, volume, issue, number of pages and if available author and article title).
4. Choose delivery format and speed. Activate “View all formats” (recommended).
